When used in this Supplement, **Prospectus Regulation** means the Regulation (EU) 2017/1129 of the European Parliament and of the Council, as amended, and the Commission Delegated Regulation (EU) 2019/980, as amended.

This Supplement constitutes a supplement to, and should be read in conjunction with, the Prospectus and the documents annexed to the Prospectus (see cif. 10 *Documents available* on page 55 of the Prospectus).

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Statements contained in this Supplement will to the extent applicable and whether expressly, by implication or otherwise, be deemed to modify or supersede statements incorporated in the Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in the Prospectus, the statements in this Supplement will prevail.

Purpose of the Supplement

The purpose of this Supplement is to update the Prospectus regarding the timetable of the Offering and the increase of the Offer Price during the Offer Periods that will run from 1 October 2023 until 22 December 2023 to a maximum of no more than EUR 22.00 per Offer Security.

Timetable of the Offering and Increase of the Offer Price

The Management Board of the Issuer resolved on 4 September 2023 to split the Sixth Offer Period into two Offer Periods and, thus, to amend the Offer Periods of the Offering according to the Prospectus as follows: The Sixth Offer Period should commence on 1 October 2023 and last until 30 November 2023 and the Seventh Offer Period should commence on 1 December 2023 and last until 22 December 2023. The Management Board of the Issuer further resolved on 4 September 2023 to increase the Offering Price from currently EUR 10.00 to a maximum of no more than EUR 22.00 during the Sixth and Seventh Offer Periods that will run from 1 October 2023 to 22 December 2023.
